1. ALL FEES DOUBLE IF ANY CONSTRUCTION IS STARTED BEFORE OBTAINING THE REQUIRED PERMIT(S).
2. ALL FEES ARE DUE AT THE TIME OF APPLICATION AND ARE NON-REFUNDABLE.
3. BUILDING PERMIT REQUIRED for One/Two-Family Residences and Commercial, Industrial, and Institutional Buildings/Structures (building inspector fees apply).
4. Interior remodeling does not require a zoning or building permit, unless a change of use is proposed (e.g., residential to commercial, accessory storage to living area, etc.). All construction shall comply with State Uniform Dwelling Code and Commercial Building Code requirements, as applicable.
5. Zoning Permit not required for structures less than 100 sq. ft., but structures shall comply with all applicable requirements of the Town of Ringle Zoning Ordinance.
6. Relocation of a structure on the same property requires a Zoning Permit.
7. Relocation of a structure from one property in the Town (Ringle Parcel "A") to another property in the Town (Ringle Parcel "B") requires a Wrecking Permit associated with Ringle Parcel "A" and a Zoning Permit associated with Ringle Parcel "B".
8. Demolition/razing of a structure or relocation of a structure from a property in the Town to a property outside of the Town requires a Wrecking Permit.

Site Plan Review Fees <i>(Note: Any required Zoning Permits or Conditional Use Permits will be considered as separate applications and fees in addition to the Site Plan Review fees.)</i>	
Solar Energy System Permit (Small-Scale, 30 kW or less)	\$150
Solar Energy System Permit (Mid-Scale, > 30 kW and < 100 MW)	\$750 plus \$1,250 professional review fee = \$2,000 deposit***
Solar Energy System Permit (Large Scale, 100 MW+)	\$1,000 plus \$2,000 professional review fee = \$3,000 deposit***
Wind Energy System Permit (Small-Scale, <=300kW)	\$750 plus \$1,250 professional review fee = \$2,000 deposit***
Wind Energy System Permit (Large-Scale, >300 kW)	\$1,000 plus \$2,000 professional review fee = \$3,000 deposit***
*** if professional fees exceed initial deposit, applicant will be liable for all fees which exceed the initial deposit.
